Management Board Meeting
Tuesday 6 October 2015
Flockton Green WMC

- Attendance:** All management board members were present except Alan Kaye and Phil Senior.
- Structure for 2016:** At present, the Management Board understands that there will be 14 clubs partaking next year (being 14 first teams and 13 second teams) but this is yet to be confirmed.
- The structure of the Huddersfield CCL will be discussed on 20 October 2015 at which point the Management Board hopes to have more information.
- Proposed Rule Changes:** The proposed rule changes will be handed out and discussed on 20 October 2015. They will then be voted upon at the AGM on 24 November 2015.
- YCB Rule Changes:** Details of the YCB rule changes for 2016 have already been circulated.
- The main change to note though is the alteration to Rule 9.3. The rule will now state "Clubs wishing to resign from any League or Association should give notice in writing before 30 June in the year previous to the season in which they intend to play in that League or Association". The rules had previously set a deadline of 30 April.
- Disciplinary Enquiries:** Edgerton and Dalton CC v Bradley and Colnebridge CC
A complaint has been made by one of the umpires in respect of the conduct of one of the players from Edgerton and Dalton CC. Players from Bradley and Colne CC that witnessed the incident are willing to corroborate the umpire's statement. Edgerton and Dalton CC have been asked to comment on the matter but no response has been received. The Management Board will, therefore, proceed to discipline the player accordingly.
- Nortonthorpe CC v Holmbridge CC
Faisal Rassool was banned from playing at Bradley and Colnebridge CC. He went on to play for Nortonthorpe CC under the name of Asif Ali. Nortonthorpe CC has confirmed that this is the case but the Management Board understands that only the captain of the team and Faisal Rassool were involved in the deceit. Both players will be disciplined appropriately. In addition, Nortonthorpe CC will lose any points that they obtained from the fixture and will be fined according to the Huddersfield CCL rules.
- Almondburians CC v Denby Grange CC
There is an ongoing enquiry in respect of the scorecard that was submitted for this game. The Management Board awaits comments from Denby Grange CC.
- Sponsorship:** The Management Board has received the news that Arrow will not be sponsoring Huddersfield CCL after the end of this year. The Management Board would like to extend their thanks to Arrow for their commitment to Huddersfield CCL over a number of years.
- The Management are actively seeking new sponsors and are hopeful that good news will follow shortly in this regard.
- Award Nominations:** The winners of all of this year's trophies have been decided with the exception of the Stallard Trophy and the Phillip Lumb Trophy. The winners will be announced at the annual dinner.
- Next Meeting:** The Management Board will meet at Flockton Green WMC on 20 October 2015 after the full league meeting.
