CORRESPONDENCE

Response received from Leymoor regarding the unprepared ground for the Leymoor B v Badger Hill B game on Saturday, 25 June 2011. On this occasion, the Management Board accept the explanation.

Response received from the Birkby Rose Hill regarding incidents involving a Birkby Rose Hill player at the Birkby Rose Hill A and Holmbridge A game on Saturday, 2 July 2011. The player was suspended for 2 matches by Birkby and the Management Board accept the actions taken, nevertheless, a letter of apology to the umpire from the player is required.

A letter of explanation from Higham has been received as to why they could not field a side for their Allsop Cup 2nd round match with Nortonthorpe on Sunday, 19 June 2011. The Management Board accept the explanation.

Response received from Bradley & Colne regarding the reported unsportsmanlike behaviour by Bradley & Colne players when they were spectators at the game between Birchencliffe B and Silkstone B on Saturday, 25 June 2011. The Management Board are satisfied with the assurances given and the action taken to ensure no further repeats.

Letter received from Upper Hopton regarding the eligibility of Crossbank player, Elliott Hallas at the Crossbank B v Upper Hopton B game on Saturday, 2 July 2011. After scrutiny of the rules, the Management Board judged the player ineligible. Crossbank to be fined £10 and lose the 6 points won. Upper Hopton will be awarded the 6 points.

Letter received from Durkar regarding the Thornhill & Westborough B v Durkar A game on Saturday, 16 July 2011, which was called off by the umpires, after a late start, due to rain. A report also received from Thornhill & Westborough. The Management Board studied both reports and decided no further action could be taken.

Letter received from Higham following the Denby B v Higham B game on Saturday, 2 July 2011. Higham report that the scorers recorded Denby opening bowler, G Potter as bowling 13 overs. The umpires have been contacted and they state that they use an umpire's scorecard and that 12 overs were recorded. The Management Board have no alternative other than to accept the umpires account. No further action to be taken.

Letter received from Heckmondwike & Carlinghow regarding overseas players. The Management Board remind all clubs about Rule 7U "A club will only be permitted to register and play 1 overseas player. For the purposes of this rule, an overseas player is defined as the holder of a non-EU passport which does not clearly state that the holder has INDEFINITE LEAVE TO REMAIN IN THE UK. The burden of proof lies with the applying club and player. A breach of this rule may result in a deduction of points".
