**CHILD WELFARE**

The new government have put on hold the proposed new vetting system for Child Welfare; therefore, clubs are advised to continue, as in past years, to ensure that all relevant people complete, if necessary, the existing CRB form.

In addition to previous Management Board, minutes there are still a number of Clubs not adhering to the ECB Fast Bowling Directive and assuming that once a player reaches 19 they no longer need to show the players age on the Team Sheet, and that they can ball 12 overs straight through, this is incorrect.

The Team Sheet states the ECB directive which says that Dates of Birth of all players who are under the age of 19 **MUST** be entered (**age group is based on age at midnight on 31 August the previous year**). That means that anyone born on or after 1st September 1990 must have their date of birth entered on the Team Sheet).

Some players are saying that they are confused because some umpires let them bowl through, and others don't.

If there is no DOB on the form, then it is taken they are over the age and that is what is causing confusion.

A reminder for clubs that players transferring from one club to another, must forward the transfer form to the Registration Secretary by 5 pm Friday for them to play on the Saturday, they cannot ask an Umpire or opposing captain to sign the form then play on the day.

When there is one umpire – League Rule 6G states the substitute umpire standing at square leg must be 16 years of age or over

## **UMPIRES APPOINTMENT SECRETARY**

Captains need to ring the Umpires Appointment Secretary before 12 pm, as per rule 5Z, to avoid umpires travelling to grounds.
