PROPOSED RULE CHANGES FOR AGM.

1. In T20 Matches where coloured clothing is worn & a RED BALL being used the Batsmen MUST WEAR WHITE BATTING PADS.

TRAINING OFFICER.

The subject of Pre Match procedure regarding the Team Sheet was clarified by Gary as follows:-

1. The Team Sheet should be completed by both teams & signed by the Captains before the Toss WHICH CAN BE BETWEEN 30 & 15 MINS. BEFORE THE START TIME.

2. The Captain, Wicketkeeper & any Junior Players should be clearly indicated with dates of birth so the Umpires can be sure the ECB Fast Bowling Directive is being implemented.

3. Once the Teamsheet HAS BEEN COMPLETED IT CANNOT BE ALTERED WITHOUT THE PERMISSION OF THE OPPOSING CAPTAIN.

4. If a player or players are arriving late the Umpires & the opposition Captain MUST BE INFORMED BEFORE THE GAME COMMENCES & INCLUDED ON TEAMSHEET. IF THEY ARRIVE 45 MINS. AFTER THE APPOINTED START TIME THEY ARE CLASSED AS A SUBSTITUTE FIELDER & CANNOT BAT, BOWL OR WICKETKEEP.

5. IF A PLAYERS NAME IS NOT ON THE SHEET BEFORE THE GAME BEGINS DUE TO THE CAPTAIN NOT KNOWING WHO THE PLAYER (S) MAY BE THE UMPIRES & CAPTAINS MUST BE NOTIFIED IMMEDIATELY THEY ARRIVE & THE OPPOSING CAPTAINS PERMISSION SOUGHT TO BE ADDED TO THE SHEET PRIOR. 45 MINUTE ALSO RULE APPLIES.

6. IF Para 4 & 5 NOT ADHERED TO THE CAPTAIN CAN REJECT THE OPPOSITIONS REQUEST FOR THE PLAYER(S) TO PARTICIPATE IN THE GAME.

1. The following items in the Handbook are highlighted more clearly:-

a. Clarify the number of points to be awarded in rained off matches where no play commences on Page 33. Rule 5.N. it states 2 points each BUT on Page40 Rule9.1. it states 3 points each.

b. Amend COPYMARK 20/20 Competition Rule U. to read 'Umpires for The Shield & Plate Finals' will be provided by the League & will be paid £30 not £25.

2. Clubs advise the Groundsman regards the Pitch Markings as indicated in MCC LAWS in particular the markings for the 'protected area' which are not indicated on Page 102 Appendix B Rules 7&9. & the position of the stumps.

3. With regards to the ECB Safety Helmets Directive Umpires are reminded to check the grill to ensure balls do not pass through the grill.
