MINUTES OF THE LAST MEETING .

UMPIRES APPOINTMENTS SECRETARY.

Graham took the opportunity of thanking the Umpires for all their support over the Season & indicated that in Season 2016 we should have sufficient Umpires to cover all our matches. He also raised his concerns that Clubs were contacting Phil Senior or Holly Buxton & not him as stated in the Handbook when matches were being called off. This had resulted in Umpires not being notified or him being unable to be allocate the Umpires to another match.

TRAINING OFFICER.

Gary suggested that when a game was over & you were on the way home, reflect on how you had performed & whether you had umpired differently at any stage during the game. This will help you maintain a consistency in controlling games especially when it comes to the end of the Season when promotion & relegation come into play.

PROPOSED RULE CHANGES.

There were 7 proposed Rule Changes 3 that were discussed & voted on so our Representative could vote for the Association at the AGM these were:

1) Rule 5(f) Page 30 of the Handbook: -

Replace the words "No fixtures, except for those classed as re-arranged fixtures, are to be played on a Sunday" with the words:

"All matches in September shall be played on a Sunday & shall commence at 1.00 pm".

2) Rule 5(f) Page 30 of the Handbook:-

Replace the words "No fixtures, except those classed as re-arranged fixtures shall be played on a Sunday" with the words:

"All matches in April & September shall be played on a Sunday".

5) Rule 6 (d) Page 33 of the Handbook:-

Replace the words "Where only one Official Umpire is in attendance then he shall receive expenses of £35 & the Substitute Umpire shall receive expenses of £10 with the words:

" Where only one Official Umpire is in attendance then he shall receive £40 & the Substitute Umpire will receive £10".

The majority of members present agreed our delegate votes for Rules 1 & 5 on our behalf. There was however a possibility that Rules 1 & 2 be combined so April & September fixtures commence at 1.00 pm if this occurred this would be supported.
