- Update on Existing Disciplinary Enquiries:**
- [Netherton B v Calder Grove A \(18 July 2015\)](#)  
There was an enquiry in respect of the team sheet but we have now been able to speak with the umpires. They have confirmed that it was them that deleted the comments section of the form and so this matter is now closed.
- [Birchencliffe B v Nortonthorpe B \(25 July 2015\)](#)  
There was an enquiry into the conduct of a number of players. This has now been resolved by way of a written warning which was sent to both clubs.
- [Leymoor A v Denby Grange A \(27 June 2015\)](#)  
A report was received in respect of the conduct of one player from Denby Grange CC. The individual involved has been warned about his behaviour verbally by Denby Grange CC. The player will also receive a written warning from the Management Board shortly.
- New Disciplinary Enquiries:** The Management Board has received a disciplinary report in respect of the conduct of a Green Moor CC player in the 20/20 final which was held at Heckmondwike and Carlinghow CC. The club have apologised for the conduct of the player and have confirmed that he is sincerely apologetic. The Management Board have decided that the player will be required to write a letter of apology to the relevant umpires. He will also be issued with a written warning about his behaviour.
