CORRESPONDENCE

In addition to this a number of Clubs are not adhering to the ECB Fast Bowling Directive and assuming that once a player reaches 19 they no longer need to show the player's age on the Team Sheet and that they can ball 12 overs straight through. THIS IS INCORRECT.

The Team Sheet states the ECB directive which says that Dates of Birth of all players who are under the age of 19 **MUST** be entered (**age group is based on age at midnight on 31 August the previous year**). That means that anyone born on or after 1 September 1990 must have their date of birth entered on the Team Sheet.

20/20 Cup

All clubs are entered into the 20/20 competition unless they opt out. Clubs should inform the league of their intention to opt out as soon as possible but no later than 1 February.

Cartworth Moor, Thornhill & Westborough, and Nortonthorpe forfeited their 20/20 matches and will be fined accordingly.
