**CORRESPONDENCE**

- The abusive behaviour reported at the Edgerton & Dalton V Nortonthorpe match on 5 July is still being investigated by H.Marsden, reports are still to be received from the Umpires.
- Edgerton & Dalton v Nortonthorpe 20/20 Final – A complaint has been received from Nortonthorpe regarding the colour of the clothing worn by Edgerton & Dalton. Nortonthorpe claimed the coloured clothes worn by Edgerton caused difficulty in seeing the ball. The game was played in daylight (SUNSHINE) with good visibility, sightscreens; and the umpires did not think there was an unfair advantage. The top score in the game was by a Nortonthorpe batter. The same clothing had been worn in previous rounds of the competition during the evening without issue. Coloured clothing was approved in the Management Board minutes of July 2012 and therefore the result of the game stands. Additional information on the issue will be included in the 20/20 rules at the AGM.
