Management Board Meeting
Tuesday 28 July 2015
Flockton Green WMC

- Attendance:** All management board members were present except Graham Foster, Alan Kaye, Clive Barrett, Andrew Matthewman and Mick Tock.
- Cup Finals:** The Alsop Cup Final was postponed due to bad weather. It will now be played on Sunday 2 August 2015 at Birchencliffe CC. Harry Marsden and Jack Carson intend to be there to represent the Management Board.
- Rearranged Fixture:** The Management Board have agreed to allow Holmbridge CC to have one rearranged fixture in the 2015 season following consideration of a letter received from the club.
- Pyramid System:** The Management Board were updated in respect of on-going discussions about the Pyramid System. The structure of that system is now being finalised by YCB and clubs will be updated at the next full league meeting.
- Higham CC:** As most clubs are now aware, Higham CC made the decision to withdraw their second team for the remainder of the 2015 season. The Management Board understands that this has been a difficult but necessary decision for Higham CC to make and will support the club in any way that it can. Phil Senior is in the process of updating the league tables and statistics.
- Get The Game On Campaign:** Management Board members have been asked to give some thought to potential rule changes that could be suggested later in the year to make our matches more flexible and player-friendly. Suggestions at present include more flexible start times, for example. Clubs are also being encouraged to give this some thought.
- Ground Reports:** The Management Board have been collating ground reports as and when they visit clubs. The reports to date (which are of about half a dozen grounds) confirm that there are no major problems at present. It is noted that there are ongoing works/improvements at Leymoor CC. Higham CC have received funding towards the costs of a new pavilion and works are expected to commence next year.
- Netherton B v Calder Grove A (18 July 2015):** There is an ongoing enquiry into an issue with the team sheet from the match between Netherton B and Calder Grove A earlier this month. Both clubs, and the umpires, have now been contacted.
- Birchencliffe B v Nortonthorpe B (25 July 2015):** There is an ongoing enquiry into the conduct of particular players during the match between Birchencliffe B and Nortonthorpe B last month. Both clubs have now been contacted.
- Nortonthorpe B v Birchencliffe B (20 June 2015):** There was an enquiry into the conduct of one player of Birchencliffe CC in respect of the cancelled fixture between Birchencliffe B and Nortonthorpe B last month. A written apology was issued by the player involved and that player has also been issued with a written warning.
- Leymoor A v Denby Grange A (27 June 2015):** The Management Board has received a report from one of the umpires of this game in respect of the conduct of a particular player from Denby Grange CC. A disciplinary enquiry is underway.
- Next Meeting:** The Management Board will meet at Flockton Green WMC on 25 August 2015.
